Chapter 1: Introduction

1.1 Overview

The Seagate® Nytro® WarpDrive® Acceleration Application cards are block storage devices. The cards present themselves to the operating system through a Fusion-MPT™ interface as single or multiple drives that require minimal user configuration. You can use these cards for either nonpersistent (for example, cache) or persistent (for example, database files) data.

The Nytro WarpDrive cards have Flash ROM for storing the BIOS and firmware, and NVRAM for storing nonvolatile user data. The cards have three LEDs on the PCI bracket to indicate activity, drive life, and status. The Nytro WarpDrive cards have a PCI Express® (PCIe®) interface that complies with the PCI Express Specification 2.0 or PCI Express Specification 3.0.

The functionality of the Nytro WarpDrive cards comes from a SAS2008 or SAS2308 I/O controller with Nytro WarpDrive firmware that runs on the internal processor.

Chapter 2: Installation

2.1 Quick Installation Instructions

You can use the quick installation instructions to install your Nytro WarpDrive card, or you can see the next section if you need more detailed installation instructions.

To guickly install your Nytro WarpDrive card, follow these instructions.

- 1. Unpack the Nytro WarpDrive card and inspect it for damage.
- 2. Turn off the server, and remove the power cord.
- 3. Remove the cover from the server.
- 4. Insert the card in an available PCIe slot.
- 5. Secure the bracket to the system's chassis.
- 6. Replace the cover and the power cord, then turn on the server.

The Nytro WarpDrive card hardware installation is complete.

2.2 Hardware Installation Instructions

2.2.1 Card Retention, Shipping, and the PCIe Specification

The PCle specification requires that add-in cards with a mass of greater than 350 grams must have additional card retention at the server level. Neither the connector nor the optional *hockey stick* feature described in the PCle specification provides the required retention.

Server OEMs and ODMs are solely responsible for choosing and qualifying their own server and rack shipping solution. Seagate does not qualify the server and rack shipping solution and is not responsible for such solution or any impact to Seagate products.

Seagate will make available mechanical design collateral for its products, which may be used by server OEMs and ODMs to design retention features for their server products. Seagate information is provided AS IS only and Seagate does not certify any design retention features used by OEMs and ODMs.

Seagate does not perform server and rack shock and vibration testing of OEM and ODM products. OEMs and ODMs are solely responsible for any server and rack shock and vibration testing.

2.2.2 Hardware Installation for the Nytro WarpDrive 6203, Nytro XP6209, Nytro XP6210 Cards

1. **Unpack the Nytro WarpDrive card and inspect it for damage.** Unpack the card in a static-free environment and follow good antistatic grounding procedures. Remove the Nytro WarpDrive card from the antistatic bag, and carefully inspect it for damage. If you notice any damage, contact Seagate, or your reseller support representative.

NOTE Back up your data before changing your system configuration.

2. **Prepare the computer.** Turn off the server, and disconnect the power cords from the power supply. Remove the cover from the chassis.


WARNING To avoid electrical shock, disconnect the server from the main power and from any networks before you install the card.

3. **Replace the PCI mounting bracket (system dependent).** If required for your system, replace the shorter PCI mounting bracket that ships on the Nytro WarpDrive card with the full-height bracket supplied. Save the two screws from the short bracket and use the screws to attach the full-height bracket.

4. **Insert the Nytro WarpDrive card in an available PCIe slot.** Locate an empty PCIe slot. Remove the blank bracket panel on the server chassis that aligns with the empty PCIe slot. Save the bracket screw, if applicable. Align the card to the PCIe slot. Press down gently, but firmly, to properly seat the card in the slot. The following figure shows how to insert the card in a PCIe slot.

5. For highest performance, make sure that the PCIe slot is PCIe 2.0 and make sure that it has an active width of dedicated eight lanes. The Nytro WarpDrive card functions with an active width of four lanes or two lanes, but with reduced performance.

CAUTION The location must meet the 300 LFM (linear feet/minute) minimum airflow requirement.

6. **Secure the bracket to the system's chassis.** Install the bracket screw, if applicable, or engage the system retention mechanism to secure the card to the system's chassis.

7. **Replace the cover, reconnect the power cords, and power up the system.** Replace the server's cover, reconnect the power cords, and reconnect any network cables. Turn on the power.

The Nytro WarpDrive card hardware installation is complete.

2.2.3 Hardware Installation for the Nytro WarpDrive 6301 Card

1. **Unpack the Nytro WarpDrive card and inspect it for damage.** Unpack the card in a static-free environment and follow good antistatic grounding procedures. Remove the Nytro WarpDrive card from the antistatic bag, and carefully inspect it for damage. If you notice any damage, contact Seagate, or your reseller support representative.

NOTE Back up your data before changing your system configuration.

2. **Prepare the computer.** Turn off the server, and disconnect the power cords from the power supply. Remove the cover from the chassis.

WARNING To avoid electrical shock, disconnect the server from the main power and from any networks before you install the card.


3. **Insert the Nytro WarpDrive card in an available PCIe slot.** Locate an empty PCIe slot. Remove the blank bracket panel on the server chassis that aligns with the empty PCIe slot. Save the bracket screw, if applicable. Align the card to the PCIe slot. Press down gently, but firmly, to properly seat the card in the slot. NOTE

Make sure that the PCle slot is capable of providing 75 W of power.

Otherwise, install the auxiliary power cable shown in the following figure. The auxiliary power cable connects to an auxiliary power supply.

4. For highest performance, make sure that the PCIe slot is PCIe 3.0 and make sure that it has an active width of eight lanes or sixteen lanes. The Nytro WarpDrive card functions with an active width of four lanes or two lanes, but with reduced performance.

CAUTION

The location must meet the 300 LFM (linear feet/minute) minimum

- airflow requirement.
- 5. **Secure the bracket to the system's chassis.** Install the bracket screw, if applicable, or engage the system retention mechanism to secure the card to the system's chassis.
- 6. **Replace the cover, reconnect the power cords, and power up the system.** Replace the server's cover, reconnect the power cords, and reconnect any network cables. Turn on the power.

The Nytro WarpDrive card hardware installation is complete.

NOTE

For all server types, do not ship the 6301 card installed or mounted inside a server. Ship the card separately and install the card into the server at its final destination. This prevents potential damage during shipment. If the card is shipped installed in a server and is damaged during shipment, the applicable warranty is void.

2.3 Software Installation Instructions

2.3.1 Windows Driver Installation

Download the latest Windows Server® 2012 R2 drivers from the Seagate website. To install the appropriate device driver, follow these steps:

2.4 BIOS Boot Support Settings

The Nytro WarpDrive BIOS permits you to change the card properties. You can specify that the card is eligible for Seagate software control or that the card is reserved for control by software that does not belong to Seagate. You can select from the following settings in the Boot Support feature of the BIOS:

Enabled BIOS and OS permits the BIOS and the operating system driver to control the card.

Enabled BIOS Only permits the BIOS to control the card. The operating system driver does not control the card. Some operating system drivers (such as Windows drivers) do not support this option.

Enabled OS Only permits the operating system to control the card. The BIOS does not control the card with this setting.

Disabled prevents the motherboard from considering the card as a boot device. Therefore you cannot boot from the card. However, you can still see the card when you use the configuration protocol, and in all other respects, the card performs as usual. You can use this option when you have multiple cards in your system and you do not plan to boot from this card.

Changes to these settings display in the Status field on the main Adapter List menu. The new setting takes effect when the BIOS reloads when you reboot the system.

Selecting Disabled prevents the user from booting the WarpDrive, but in all other respects the WarpDrive will work the same.

2.4.1 Changing the BIOS Settings

To change the BIOS settings, follow these instructions:

1. At power-on, press Ctrl-C to log on to the BIOS screen.

BIOS This tool is available only during boot. Use this tool to view information about the card and to configure the boot support options. See BIOS Boot Support Settings.

DDCLI This menu-driven, command line interface tool permits you to view information, view the status, and flash upgrade the firmware for the Nytro WarpDrive card. Refer to the Seagate® Nytro® WarpDrive® Application Acceleration Card Management Utility User Guide.

Chapter 3: Characteristics

This chapter presents characteristics for each Nytro WarpDrive card.


3.1 Nytro WarpDrive 6203 Card Characteristics

The Nytro WarpDrive 6203 card uses a low-profile, half-height, and half-length PCIe board.

The Nytro WarpDrive 6203 card uses a SAS2008 controller with drive firmware that runs on its internal processor. The controller connects to up to four embedded nonvolatile memory modules. The Nytro WarpDrive 6203 card can be used for either persistent or nonpersistent data and offers high-performance with low latency and a low CPU burden.

The following figure shows the Nytro WarpDrive 6203 card.

3.1.1 LEDs

Three board-mounted, right-angle LEDs shine through holes in the PCI bracket: one is for data activity, one is for drive life, and one is for drive status. The LEDs are labeled on the bracket.

3.1.2 Troubleshooting the Nytro WarpDrive Card

The LEDs provide key status information to diagnose any problem with the Nytro WarpDrive card. You can also contact Seagate Technology Support Services. The following figure shows the LED layout.

Figure 7 Nytro WarpDrive 6203 Card LED Diagram



Figure 9 Nytro XP6209 LED Diagram





Figure 11 Nytro WarpDrive 6210 Card LED Diagram



Figure 13 Nytro WarpDrive Card LED Diagram



3.4.4 Power Consumption for the Nytro WarpDrive 6301 Card

The Nytro WarpDrive 6301 card draws its main power for operation from either the 12-V PCle power rail, or from an external 12-V power supply through the auxiliary power cable. Power comes from only one of these sources, not both. Attaching the power cable causes the board to select the cable as the source of power.

The Nytro WarpDrive 6301 card monitors the PCIe 3.3V rail to determine if the host server has lost power on this rail, but the power consumed from this rail is negligible.

The PCle 3.3V auxiliary rail powers a small nonvolatile memory on the Nytro WarpDrive 6301 card so that this memory can update through the system management bus on the PCle connector. Compared to the power consumed during Nytro WarpDrive 6301 card normal operation, the power consumed by the PCle 3.3V auxiliary rail is negligible.

For the Nytro WarpDrive 6301 card, sequential writes of 100 percent with an I/O size of 64 KB consumed the most power. Seagate measured power consumption from the 12-V rail and the 3.3-V rails under a number of I/O loading conditions to find this result.

Seagate tested an eight drive module configuration using 256-GB drive modules. The maximum power consumption was 46.3 W during 64 thousand sequential writes.

Use the following data for power consumption measured with an I/O size of 64 KB:

- 12.0-V DC at 3.86 Amps (46.3 W)
- 3.3-V DC at 0.0 Amps (0.0 W)
- 3.3-V aux DC at 0.006 Amps (0.02 W)

3.4.5 Qualified Servers for the Nytro WarpDrive 6301 Card

Seagate has qualified servers that support the card and that provide the correct thermal conditions to deliver the full operating performance.

Due to unique weight, power consumption, and thermal dissipation requirements, the Nytro WarpDrive 6301 cards are recommended for operation in servers that Seagate has qualified. Servers on the Seagate qualified server list are tested in Seagate labs and confirmed to offer sufficient power and thermal support. Some adjustment to factory servers settings might be necessary to achieve correct power and thermal settings. Contact your sales representative for additional details. The following list provides information and requirements for the Nytro WarpDrive 6301 card. If you do not meet these requirements, you void the applicable card warranty.

- Weight: For all server types, do not ship the card installed or mounted inside a server. Ship the card separately, and install the cards into the server at the final destination. This action prevents potential damage during shipment. If the card is shipped installed in a server and is damaged during shipment, the applicable warranty is void.
- **Power Consumption:** The card consumes a maximum of 46.3 W of power to operate at full performance. If a target PCle® slot does not supply this amount of power, you must use the auxiliary power cable that ships with each card. Insufficient power availability does constrain the performance capabilities of the card.
- **Thermals:** You must install and operate the card with the correct thermal envelope with sufficient airflow. Fan setting and placement of the card are critical to maintaining optimal performance and endurance. Because of thermal constraints, you must provide a minimum of 300 LFM to the card.

- Relative humidity range: 5 % to 95 % noncondensing
