# Seagate® Bonus E-Gift Card Promotion May 2025

### **OFFICIAL RULES**

These Official Rules ("Rules") govern the Promotion. If you do not agree with these Rules, do not participate in this Promotion or accept a Promotion Giveaway (as defined below). Participation in this Promotion (including any acceptance of a Promotion Giveaway) is deemed acceptance of these Rules.

### 1. GENERAL

1.1 **Description of the Promotion**. End user customers who purchase at least one (1) unit of Seagate IronWolf, IronWolf Pro, Exos or SkyHawk 4TB+ product (as identified in Subsection 2.1 below) from an Eligible Reseller (as defined in Subsection 2.1 below) during the Promotion Period (as defined in Subsection 1.2 below) and submits the proof of purchase online as instructed in Section 2 below, will be eligible to claim a bonus digital e-Gift card (hereafter referred to as the "Promotion Giveaways") based on the specifications outlined in subsection 3.1 below. Regardless of the number of eligible purchases or transactions made, a maximum of five (5) gift card claims are permitted per person (for maximum 5 HDD purchased).

Claims will be reviewed on a first come first serve basis and valid claims who submit before the prize pool is exhausted will be awarded the relevant e-gift card with denominations outlined in table A. Gift cards will be distributed via email from third party GoGift or similar gift card provider available in the country of claimant. Gift cards will be distributed up to 8 weeks from close of Promotion Period. If the total prize pool is exhausted before the Promotion end date, the Promotion Website outlined in Subsection 2.2 will disclose that the Promotion has closed.

- 1.2 **Promotion Period.** The Promotion commences at 00:00 SGT 21st May 2025 (02:00 21st May 2025 AEST) and 23:59 SGT 21st July 2025 (02:00 21st July 2025 AEST) or until prize pool has been exhausted (whichever occurs first) (the "Promotion Period").
- 1.3 **Purchase Period.** To be eligible for this Promotion, end user customers must complete an Eligible Purchase (as defined in Subsection 2.1 below) from an Eligible Reseller (as defined in Subsection 2.1 below) during the Promotion Period and submit their entry materials online as instructed below during the Entry Period (as defined in Subsection 1.4 below.)
- 1.4 **Claim Period.** Each participant must register their Eligible Purchase online at: <a href="https://www.seagate.com/as/en/promos/giftcard-promo-2025-ph">https://www.seagate.com/as/en/promos/giftcard-promo-2025-ph</a>, between 21st May 2025 (02:00 21st July 2025 (02:00 21st July 2025 AEST) or before prize pool has been exhausted (whichever occurs first) (the "Promotion Period").
- 1.5 **Promoter.** The "Promoter" of this Promotion is Seagate Technology Australia Pty Limited (the "Promoter") (ABN: 87003840328) Level 1, 93 George Street, Parramatta, NSW, 2150, Australia.
- 1.6 **Exclusions**. Employees of the Promoter and its subsidiaries and affiliates, and employees of their agents or individuals involved in any part of the administration of this Promotion, and each of any employee's immediate family members (parent, sibling, spouse, and children) and household members, Seagate channel partners, Seagate authorized distributors, Seagate retailers and their subsidiaries are excluded from eligibility in this Promotion. The Promoter is committed to complying with government gift and ethics rules and therefore government employees are not eligible to participate in this promotion.

### 2. ENTRY AND PARTICIPATION

2.1 Eligibility. ONLY OPEN ONLY TO LEGAL RESIDENTS OF THE PHILLIPINES WHO ARE 18 YEARS OR OLDER AS OF THE DATE OF ENTRY. For this Promotion, "Eligible Product" is limited to Seagate IronWolf, IronWolf Pro, Exos and SkyHawk HDD listed in the table in Section 3.1. An "Eligible Purchase" is the purchase of at least one (1) Eligible Product from an Eligible Reseller.

"Eligible Resellers" are all of Promoter's authorized resellers and retailers located in the Philippines or Promoter's authorized online Seagate e-tailers. Participation in the Promotion is limited to end user customers who purchase the Eligible Product for end use and not for resale purposes. This Promotion is void outside the Philippines and where prohibited by law.

2.2 **Entry Process**. In order to participate in this Promotion, the end user customer must complete an Eligible Purchase from an Eligible Reseller and submit the receipt as proof of purchase (a "Entry") online at <a href="https://www.seagate.com/as/en/promos/giftcard-promo-2025-ph">https://www.seagate.com/as/en/promos/giftcard-promo-2025-ph</a> during the Entry Period.

The entrant must retain proof of purchase. The proof of purchase required is a copy of the receipt or invoice for the qualifying transaction. Purchase orders will not be accepted. If a participant fails to produce the Proof of Purchase for a specific claim or each claim as and when requested by the Sponsor, the Sponsor has the right to invalidate the participant's respective claim for which Proof of Purchase cannot be provided and/or all claims submitted by that entrant and/or forfeit the entrant's right to a promotion giveaway.
