



## SAS Firmware Update Instructions



### Exos 7E10 SAS STD 512N firmware update version **N004**

This firmware update is for the Seagate Exos 7E10 SAS family only.

Backup all data contained on the drive prior to running the update.

See the End User License Agreement below for specific information about these software tools.

This firmware release only supports the following models:

**Note:** The firmware above does NOT support SATA, SED or FIPS. It is only for the three models in the list above.

If your current **Exos 7E8** SAS HDD firmware does not begin with the digits “N001” or “N002” or “N003” then you have a configuration which is not compatible with N004. Otherwise, you might have a unique OEM version in which case please contact your OEM for firmware updates for these drives.

**Warning, possible loss of data if this firmware is downloaded to unsupported models!**

DO NOT run this firmware update on RAID systems.  
DO NOT turn the power off during the firmware update procedure.

BEFORE YOU BEGIN:

1. Make sure you have backed up all of your important files and critical data.
2. Save any work in progress.
3. Close all other open applications.
4. Disconnect all external storage devices.

Always handle the drive carefully so you do not cause internal damage to the heads and media inside the drives. Drives are sensitive devices.

### **A warning about RAID**

RAID systems are extremely sensitive to disruptions to individual drives. It is not uncommon for low level disk drive diagnostics to cause RAID management software to fault a drive that is slowed down by testing or firmware download. For this reason, we highly recommend that you use disk management tools provided by your RAID controller manufacturer if they are available. If these tools are not available, you might consider taking the RAID offline to a maintenance mode or rebooting the system to temporary bootable media and running diagnostics from there. Seagate recommends that you use disk utility tools provided by your RAID controller manufacturer.

Among others, RAID management software is available from 3Ware, Adaptec and LSI.

### **Here are the instructions for updating SAS firmware:**

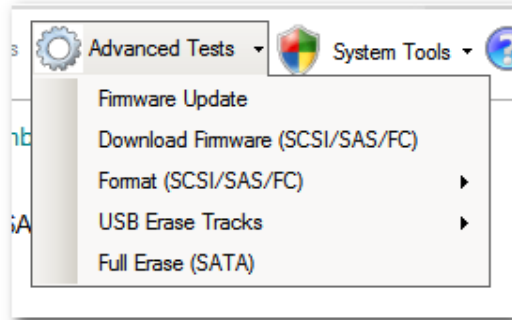
The method you choose to update the firmware on the drive will depend on your operating system, system utilities or work bench environment.

#### Windows Tool

Windows operating systems tolerate firmware downloads to SAS disk drives in JBOD mode. Drives in RAID configurations should not be given new firmware unless a special tool is provided by the RAID controller manufacturer.

Seagate’s SeaTools for Windows may be used to download firmware to SAS disk drives in JBOD mode. You will find SeaTools for Windows at

[www.seagate.com/support/seatools](http://www.seagate.com/support/seatools) and select the Downloads tab. After SeaTools is installed on the system, you will find *Download Firmware (SCSI/SAS/FC)* on the Advanced Tests menu.



The firmware files will be either .LOD or .SEA file types.

**Important:** These files must be copied to the SeaTools for Windows folder.

## Command Line Interface Tools

SeaChest\_Firmware is available for firmware download. SeaChest\_Firmware is available for both Linux and Windows and they share the same command line structure. These tools have extensive documentation available.

Note: Windows operating systems do NOT allow firmware download to SATA drives unless the drives support the Deferred Download mode.

**SeaChest\_Firmware** is our most current tool. The Linux version is shown below. The Windows version does not reference devices as “/dev/sg” but rather as PDx. Please see the SeaChest\_Firmware for Windows documentation for specific examples.

First, run the `--scan` option to determine what `/dev/sg#` assignment lines up to your disk drive. This option also will show you other details about the drive including the current firmware revision. Like this:

Vendor	Handle	Model Number	Serial Number	FwRev
ATA	/dev/sg0	ST94813AS	3AA043KP	3.03
SEAGATE	/dev/sg1	ST1000NM0011	ZAA15VAS	SN03

The typical ordinary command line looks something like this:

```
SeaChest_Firmware -d /dev/sg2 --downloadFW fwfilename
```

`--modelMatch` is a model number verification based on the device Inquiry response. `--modelMatch` scans all sg devices on the system.

The tool has two batch modes, which can be used thusly:

```
SeaChest_Firmware -d all --modelMatch <model_number> --downloadFW fwfilename
```

Note: Use of `-d all --modelMatch` mode is preferred for batch processing of sg (SCSI generic) SAS disk drives. The `--modelMatch` mode may also be used on Enterprise SATA disk drives. Desktop and notebook SATA drives firmware is usually combined with a Seagate-prepared CFS firmware configuration file.

The `<cfs_file>` noted above is a Seagate-prepared compatible firmware selector file which is used to match up the right firmware for a particular SATA drive.

```
SeaChest_Firmware -d /dev/sg2 --fwdlConfig configfile.cfs
```

Note: Batch processing of SATA drives should use a Seagate prepared CFS file.

Both of these modes assume that the relevant firmware files are located in the current working directory.

See the `SeaChest_Firmware.txt` file for a complete description of the software.

## Raw Firmware Data Files

You will need the Seagate firmware file to run the simple command line Linux tool. This file will have the .LOD filename extension and should be located in the current working directory. This firmware file should never be used outside of the specific product family models and part numbers listed with the firmware release. Incorrect usage of the .LOD may result in data loss or even product failure. Seagate Technology is not responsible for lost user data. See the End User License Agreement below for specific information about these software tools.

## Using Traditional Linux Firmware Tools

For SAS drive firmware downloads you might use the Linux "sg\_write\_buffer" command. The sg command stands for the (SCSI Generic driver) and is an off-the-shelf Linux command that is kept updated by the Linux community. It may be able to work with various RAID cards and see the individual drives. You will need to load the "sg3\_utils" package if not already in your Linux kernel.

For Ubuntu \_ apt-get sg3\_utils

For Fedora/redhat/centros yum install sg3\_utils

1. Be in the directory where the .lod files is located then run the sg\_write\_buffer cmd. More details below.
2. On larger code files you must specify --length=file size. Use ls -l command to get the file size of the code (to use in the sg\_write\_buffer command string

# ls -l ST9600205SS_0002_servo-x106.lod

3. Identify the /dev/sgx device. Run the lsscsi -g command to see target devices /dev/sg#

4. Run sg\_write\_buffer command to the target device. Here is an example of a firmware download to a Seagate Constellation ES.1 model ST9600205SS:

# sg_write_buffer -v --in=/var/tmp/ST9600205SS_0002.lod --length=1238016 --mode=5
/dev/sg3
Write buffer cmd: 3b 05 00 00 00 00 12 e4 00 00
```

Or sg\_write\_buffer -v --in=<fw file name> -l=<file size> -m=5

5. Then use Linux SMARTCTL to verify what code is on the disk

  - 0) Convey the Minimal Corresponding Source under the terms of this License, and the Corresponding Application Code in a form suitable for, and under terms that permit, the user to recombine or relink the Application with a modified version of the Linked Version to produce a modified Combined Work, in the manner specified by section 6 of the GNU GPL for conveying Corresponding Source.
  - 1) Use a suitable shared library mechanism for linking with the Library. A suitable mechanism is one that (a) uses at run time a copy of the Library already present on the user's computer system, and (b) will operate properly with a modified version of the Library that is interface-compatible with the Linked Version.
- e) Provide Installation Information, but only if you would otherwise be required to provide such information under section 6 of the GNU GPL, and only to the extent that such information is necessary to install and execute a modified version of the Combined Work produced by recombining or relinking the Application with a modified version of the Linked Version. (If you use option 4d0, the Installation Information must accompany the Minimal Corresponding Source and Corresponding Application Code. If you use option 4d1, you must provide the Installation Information in the manner specified by section 6 of the GNU GPL for conveying Corresponding Source.)

## **5. Combined Libraries.**

You may place library facilities that are a work based on the Library side by side in a single library together with other library facilities that are not Applications and are not covered by this License, and convey such a combined library under terms of your choice, if you do both of the following:

- a) Accompany the combined library with a copy of the same work based on the Library, uncombined with any other library facilities, conveyed under the terms of this License.
- b) Give prominent notice with the combined library that part of it is a work based on the Library, and explaining where to find the accompanying uncombined form of the same work.

## **6. Revised Versions of the GNU Lesser General Public License.**

The Free Software Foundation may publish revised and/or new versions of the GNU Lesser General Public License from time to time. Such new versions will be similar in spirit to the present version, but may differ in detail to address new problems or concerns.

Each version is given a distinguishing version number. If the Library as you received it specifies that a certain numbered version of the GNU Lesser General Public License “or any later version” applies to it, you have the option of following the terms and conditions either of that published version or of any later version published by the Free Software Foundation. If the Library as you received it does not specify a version number of the GNU Lesser General Public License, you may choose any version of the GNU Lesser General Public License ever published by the Free Software Foundation.

If the Library as you received it specifies that a proxy can decide whether future versions of the GNU Lesser General Public License shall apply, that proxy's public statement of acceptance of any version is permanent authorization for you to choose that version for the Library.
